Someone asked about recording addresses and they could see this is possible when you open the

**Individuals Information** (person of interest) and look for the little house near the top of the page. This is where you add or edit mailing address information.

Under View is the option to choose your Preferred Family Startup, or CtrlS.

**Also under View is Ages**, which will tell you in years, months and days exactly how old a person was when they married. The length of the marriage and how long ago it was.

**Under Add** we could include an unlinked person. This is great for adding a partner when there has been no marriage.

**Under Edit** just as we can add a second husband or wife, we can also add biological parents.

There were lots of other little gems included and hopefully we all came away with the information we needed.

However it is possible to obtain these records for deceased WW2 service personnel from the NZ Defence Force archive at Trentham and further info regarding this is shown on the following link.

Down near the bottom of the page they advise what details you require in order to locate the correct files etc. You can then click on the Contact Form and submit the details and change the "Enquiry type" from Medals to Personnel Archives.

As long as the person you are enquiring about is deceased there is no issue. However if the person is still alive then only they can apply for the records.

I just added a headstone photo & a link from the Invercargill Cemetery when I asked for my father's records.

### **Irish Ancestors**

This is a site created by John Grenham, author of **Tracing Your Irish Ancestors, 5th edition** and one of the best known Irish genealogists.

It would be unusual if a day went by that I didn't use this site (it would probably mean that I wasn't doing any research that day). You will not find a record on your specific ancestor, but it will tell you what records are available for the time and place where your ancestor lived.

When you arrive at the **Home** page for the site you're greeted with a beautiful picture of Ireland (which changes regularly) and a flashing cursor that invites you to type in a surname. What? Didn't I just say it's not for finding records on your ancestors? This will take you to a surname distribution of where in Ire- land your name is found.

If you have a common name, such as Daly, the dots will appear over all of Ireland. How- ever, if you have an unusual name, such as Moughty, you may find the name isolated to a small area. The information used to create these maps is taken from Griffith's Valuation done between 1847 and 1864, but even if your ancestors left earlier, the chances are that some of the family remained behind.

Note: I. had to modify the spelling of Moughty to Mughty as that was the spelling in Griffith's. There were only 4 families in all of Ireland with that name versus 3,865 Dalys. This page will also provide you in the upper right with all of the spelling variations of the name.

Cyndi's List is an online index for genealogists, pointing to just about any website that might help in their research. According to the website, Cyndi's List has been a trusted genealogy research site for more than 20 years. Cyndi's List is free for everyone to use and it is meant to be your starting point when researching online.

What exactly is Cyndi's List?

A categorized and cross-referenced index to genealogical resources on the Internet.

A list of links that point you to genealogical research sites online.

A free jumping-off point for you to use in your online research.

A "card catalogue" to the genealogical collection in the immense library that is the Internet.

Your genealogical research portal onto the Internet. Even if you're fairly comfortable with seeking out New Zealand sources, how are you with other countries? I find even Australia can be a challenge because I don't very often have to look there. But as I broaden my searches to hunt down DNA matches I'm finding lots of blank moments and empty screens as I look for basic sites.

Cyndi has 1651 Australian sites to look through covering just about every topic you could think of -immigration and emigration, convicts and prisons, photographs and memories, queries and surname lists. Whatever you are trying to find, Cyndi should be able to help you find it. I found my way to the Black Sheep Search website at https://www.black-sheep-search.co.uk/ which is a fascinating read even if you have no black sheep. March 5, 2020 — Mobile App Fan Chart Update

FamilySearch.org users now have more printing options for the fan chart display on Family Tree. Not only can they print a fan chart that shows up to seven generations, but any of the seven fan chart views can be printed. These views include Family Lines, Birth Country, Sources, Stories, Photos, Research Helps, and Ordinances.

The FamilySearch Family Tree app now has a new way to see your family story—the fan chart, which was previously available only on a laptop or desktop! To turn on this feature, go to your app settings, and select **Enable Fan Chart View**. You can toggle this selection on or off as desired.

Chances are your ancestors are already included and that you need not be put off by

thinking "but I've x000 people to input if I start again on yet another tree".

You will have a gateway ancestor to link to, somewhere on your tree that makes life easier, and leaves the tree healthier, less duplicated and of course well sourced for the future generations. *eg using RootsMagic* (RM), start with your closest ancestor no longer living, do the search from within RM on the FamilySearch tree, select a match if there is one.

Switch to the FamilySearch tree using the *show* in FamilyTree option, tidy up the FamilySearch tree by merging duplicates (after checking of course!) add sources, missing data. Then go back into RM and match/import as you go back up your family of interest. You will be very unlucky if you have to do a lot of keying.

Regardless of where you put your tree online, be mindful of basic input guidelines, which are covered well in this series of articles, of which the link is to the first https://www.dataminingdna.com/indepth-guide-to-ancestry-part-1-the-essential-tree/

## About 1939 England and Wales Register Historical Context

Initially taken due to the onset of war with the purpose of producing National Identity Cards, the register later came to be multi-functional,

Cards, the register later came to be multi-functional, first as an aid in the use of ration books and later helping officials record the movement of the civilian population over the following decades and from 1948, as the basis for the National Health Service Register.

The 1939 Register is an extremely important genealogical resource, not only for the rich detail and information recorded for each person and household, but also in helping to bridge a thirty-year gap in census data.

The census taken in 1931 was destroyed during the Second World War and no census was carried out in 1941 due to the ongoing conflict.

The register, as held by The National Archives, contains data only for England and Wales and does not include records from households in Scotland, Northern Ireland, the Channel Islands or the Isle of Man.

Enumerators collected the data on 29th September 1939. Volumes were organized by place (District or County - see codes below) and then by Enumeration District, represented by a four or five letter code followed by two numbers. These codes were largely based on the 1931 census enumeration units.

Letter Codes for Boroughs and Districts:

- RD Rural District
- UD Urban District
- MB Municipal Borough
- CB County Borough
- Met B Metropolitan Borough

You may be able to find the following information (where available): Name, Gender. Address, Date of Birth, Marital Status, Occupation, Whether Visitor, Officer, Servant, Patient or Inmate, Inferred family members, Other members of the household
